## Dear Ms. Martinez:

I have been and continue to be denied access to justice due to violations of law and procedure by members of your staff. I ask that you take these civil rights matters seriously and immediately correct the following:

- On repeated occasions I have sought to speak to technology specialist or supervisor in order to correct false service contact information for myself that was entered without my consent and that is not accurate. My service contact as duly recorded in Court filings and as entered by myself in Odyssey File and Serve is the mailing address above. I continue to be denied access to justice until my service contact is corrected.
- I have on various occasions been mocked, derided and lied to by members of your staff;
   please ensure individuals representing your office communicate civilly and ethically to all
   litigants regardless of the litigant's personal characteristics and identity.
- Your staff routinely refuse to certify my documents filed as a pro se litigant. I demand
  efficient access to justice as is available to any litigant regardless of financial status or
  legal representation.
- Your staff routinely refuse to provide a name and title when communicating with me via email; as they are representing the court, this is unacceptable and they must be instructed to identify themselves when asked.

Your staff routinely offer unsolicited false legal advice that is intended to curb litigants'
access to justice, for example advising me that circuit court documents ought to be filed
in appellate court and refusing to certify documents until I ask for help from the Court's
legal Counsel, Injustice Watch, The State and Federal Civil Rights monitoring bodies.
They are all tired of these emails and so am I. This is unacceptable.
