Dear Mr. Murphy-Aguilu:

I have been attempting to stop violations of my civil rights within the clerk's office, including fraud, for nearly a year. I have only now become aware of the existence of your office after extensive email exchanges with Court attorney Brianna Steger, multiple requests to clerks for contact information for supervisors, and multiple reports of abuse to attorneys judges and clerks. I hope that you'll be able to swiftly remedy this disgusting situation.

I need immediate resolution to the following:

- 1. On multiple occasions my service address has been fraudulently changed in order to keep me from being notified of court actions and hearings. This has resulted in at least returned court notices on the docket and at least four scheduled court appearances I was not informed about. I have a right to be served as any other litigat does. Correct my service details to reflect:
- a. I am pro se. At present and three other attorneys are listed. I have confirmed with my last attorney, that she did not enter this information and she has no way to remove it. I have made countless attempts to have this removed. Please intervene.
- b. In one of the early efforts to stop me receiving service my address was changed from 423 Linden Ave. Wilmette to 423 Linda Ave. *Chicago*. My current address is 419 Greenleaf Ave., Willmette, IL 60091. At present the fraudulent service details for inclinde the address 423 Linda for Merel and Associates. Please intervene.
- 2. Court employees routinely email me anonymously and refuse to provide their name, title and contact information. By attempting to anonymously instruct or influence me under the authority of the Clerk/Court email server and title they violate the concept of transparency central to our justice system. This is an unacceptable use of public resources and abuses authority. Clerks are not entitled to represent themselves as the Court itself when performing duties. Please intervene.
- 3. Clerks have commanded me to appear in Court by "Court order", absent an actual order by a judge. Specifically, when I attempted to subpoena Kaye Mason, who had participated and witnessed in a solicitation of bribery by email, she then wrote me that "The Court" orders me to appear before Judge Johnson, for whom she's a scheduler. "The Court" does not command citizens by email. "The Court", like all of us, is bound by law. Please intervene.
- 4. See above, witness of bribery by a clerk. Please intervene.

Please confirm receipt and advise me of what actions you've taken to remedy the above.
