Hi All,

Omitted were exhibits in support of my response, attaching here. I will make certain they are included in the record. Will also be providing notes from Doctors Brunner and Smith who are unable to attend on short notice but are happy to testify in the future, which will also be included on the record and available today. I also wanted parties, particularly Mr. Bender, to know that the boys and Peter have covid. Per school guidelines boys need to stay home with me today and tomorrow. I will have both boys here during trial and make every effort to have them stay out of the room. But we should expect that, unless the hearing is delayed, the boys will be exposed to the litigation, particularly A [REDACTED] who has challenges with self regulation and needs a lot of active adult support. I fear this will create a conflict for me as I have a legal and moral authority to tell the truth and advocate for my children's well being. However I am also required by my duly enacted parenting plan and general family law principal not to disparage the children's father. I don't think this conflict is healthy or good for the judicial process.


















It's my opinion that it would be better to delay to avoid them hearing these discussions and I ask Mr. Wehrman and Mr. Bender to provide their opinions as Mr. Bender in particular has been given authority by Judge Johnson to make decisions on his behalf.

Mr. Bender, do you support the minor children being in hearing of today's trial? Do you have any other suggestions? I cannot use the court child care because of their Covid status. I cannot send them to school. I cannot hire a child care provider knowing my children are quarantined. Mr. Bender, would you please propose a new trial date/time that protects my children's interests?
