I have confirmed that Dr. Blechman is well. I received a call back from Officer Justin Sanchez from the Wheaton Police Department today at around 12:30 pm from phone number (630) 386-5692. Officer Sanchez advised me that Dr. Blechman did not wish to have any contact with me based on advice he's received from legal counsel. I imagine this is due to the fact that Dr. Blechman faces serious civil and criminal penalties for acts I have alleged he committed in an ongoing federal lawsuit. Officer Sanchez said he advised me that it is in my interest not to have any more contact with Dr. Blechman. The conflict is obvious and I agree with Dr. Blechman's opinion that Dr. Blechman can no longer serve in this matter.

Shall I draft an order of Dr. Blechman to step down as he's clearly stated to an officer of the law that he is both unwilling and unable to perform the duties assigned to him?
