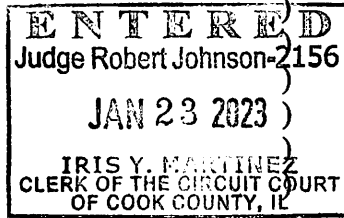

ORDER

This cause coming before the Court for a case status hearing and return on emergency order of protection and Megan Matt's presentment of her Section 2-1401 Petition for Relief from Judgment in August 21, 2020 Ruling of Contempt of Court and Peter Matt's Motion to Modify Child Support, Child Expenses, Tax Allocation and Other Relief, Peter Matt appearing with counsel, Megan Matt appearing on her own behalf, and the Guardian Ad Litem appearing, and the Court being advised:

IT IS HEREBY ORDERED:

1. A Hearing on Peter Matt's Emergency Petition for Order of Protection is set for March 8, 2023 at 10:00 a.m., in person in courtroom 2108, and a disposition order regarding same is entered contemporaneously herein.
2. Peter Matt has 28 days to respond to Megan Matt's Section 2-1401 Petition for Relief from Judgment in August 21, 2020 Ruling of Contempt of Court and Megan Matt has 28 days to respond to Peter Matt's Motion to Modify Child Support, Child Expenses, Tax Allocation and Other Relief.
3. A Hearing on Peter Matt's Motion to Quash Subpoena; Peter Matt's Motion to Modify Child Support, Child Expenses, Tax Allocation and Other Relief; Peter Matt's Motion for Section 508(b) Fees; GAL's Petition for Rule to Show Cause And for a Finding of Indirect Civil Contempt against Megan Matt; and, Megan Matt's Motion for Allocation of GAL Fees, Extraordinary Healthcare Costs, 604B Investigation Costs, and Attorney Fees for Megan Mason; and, Megan Matt's Section 2-1401 Petition for Relief from Judgment in August 21, 2020 Ruling of Contempt of Court are set for May 2, 2023 at 1:00 p.m. in person in Courtroom 2108.
4. Ruling on the amount of attorney's fees awarded to Peter Matt as a sanction for Megan Matt's violation of Rule 137 pursuant to the August 7, 2022 Order shall be made on May 2, 2023 at 1:00 p.m.;

5. All other orders remain in full force and effect;
