

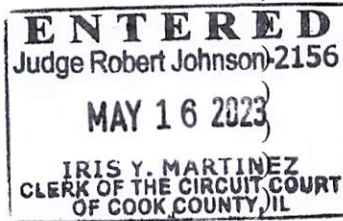

ORDER

This cause coming before the Court for an in-person evidentiary hearing on Megan Matt's ability to pay for a Rule 215 examination and Peter Matt's motion to modify child support, child related expenses, tax allocation, and other relief filed on January 18, 2023, Peter Matt appearing with Counsel, Megan Matt appearing on her own behalf, the GAL being present, and the Court being advised:

IT IS HEREBY ORDERED:

1. Megan Matt is found to have the ability to pay for a Rule 215 examination and shall solely responsible to pay for same.
2. Dr. Robert Siegel (250 Parkway Dr., Ste. 150, Lincolnshire, IL 60069 (312/401-0068) is appointed as the Rule 215 examiner. Both parties and the GAL shall cooperate with Dr. Siegel to provide information, pleadings, discovery, and any other information for the evaluation and report of Dr. Siegel.
3. Peter Matt's motion to modify child support, child related expenses, tax allocation, and other relief filed on January 18, 2023 is granted. Based upon Peter Matt's gross monthly income of \$6,737 per month and Megan Matt's gross monthly income of \$8,825 per month, child support is set at \$1,459 per month, to be paid through the SDU via a Uniform Order of Support.
  - a. Megan Matt shall pay retroactive child support as of January 18, 2023 to present totaling \$5,836.00 at the rate of \$100.00 per month pursuant to a Uniform Order of Support.
  - b. Megan Matt shall pay \$300.00 per month as and for contribution to child related expenses. Within 45 days of the end of the calendar year, the parties shall

exchange expenses incurred for the children and within 30 days thereafter shall equalize the payments under the Marital Settlement Agreement on a 50/50 basis.

- c. Beginning with the 2023 tax returns, Peter Matt shall solely be allocated the right to claim the children as dependents on his tax returns.
4. Peter Matt's Second Motion for Section 508(b) Attorney's Fees filed on June 4, 2022; Ruling on the amount of attorney's fees Megan Matt shall pay to Peter Matt pursuant to the Rule 137 sanctions per the Court's August 3, 2022 Order; Peter Matt's Petition for Rule to Show Cause filed on March 3, 2023; Peter Matt's Motion for Attorney's Fees Pursuant to 60/214(b)(13) filed on May 2, 2023; Megan Matt's Motion for Allocation of GAL Fees, Extraordinary Healthcare Costs, 604B Investigation Costs, and Attorney Fees for Megan Mason; Megan Matt's Section 2-401 Petition for Relief from Judgment in August 21, 2020 Ruling of Contempt of Court; Megan Matt's Motion to Vacate Plenary Order of Protection Entered in this Court Against Megan Mason on March 8, 2023, and the GAL's Petition for Rule to Show Cause are set for hearing on July 14, 2023 at 1:00 p.m.
5. On the Court's motion, Megan Matt shall not file any further pleadings until first receiving leave of Court to do so.
