Kaye,

That's not appropriate. Mr. Bender has scheduled a motion to present tomorrow. I have received no notice that he has changed his date. I go by the docket and the law. I have received a notice that Bender will be there tomorrow. I'm legally entitled to be there and to present my motion to dismiss Bender's illegal action. I require formal notice because of longstanding fraud by you and other parties in this case.

You and Robert Johnson have a history of facilitating court hearings without notifying me or allowing me to attend. The first instance occurred in December, 2019 when either you or Robert Johnson filed a false appearance on my behalf,

knowing that I had never met you or Mr. Johnson and did not even know that he was assigned as a judge to hear post-decree motions after my divorce was concluded. You or Mr. Johnson also filed another fraudulent appearance purporting to be on my behalf in July, 2020. I will not pretend that I think you are a good human because I've seen you participate in and hide serious acts of corruption that have harmed my children. But Kaye, most of your co-conspirators are wealthy doctors and attorneys. You are not. The judges will get good state's attorneys to try to protect the power of judges. You won't. Blechman, Wehrman and Johnson all have attorneys protecting them because they are the smartest ones. Their attorneys will try to put it on you, Kaye. All of it. But there is also a benefit to you being low on the totem pole. If you call the FBI now, you could very well avoid jail time, maybe even prevent large swaths of people hating you once this racketeering case is made public.

I don't think you're as stupid as Bender, Palen, Trowbridge and Peter Matt. Stop acting like you are.

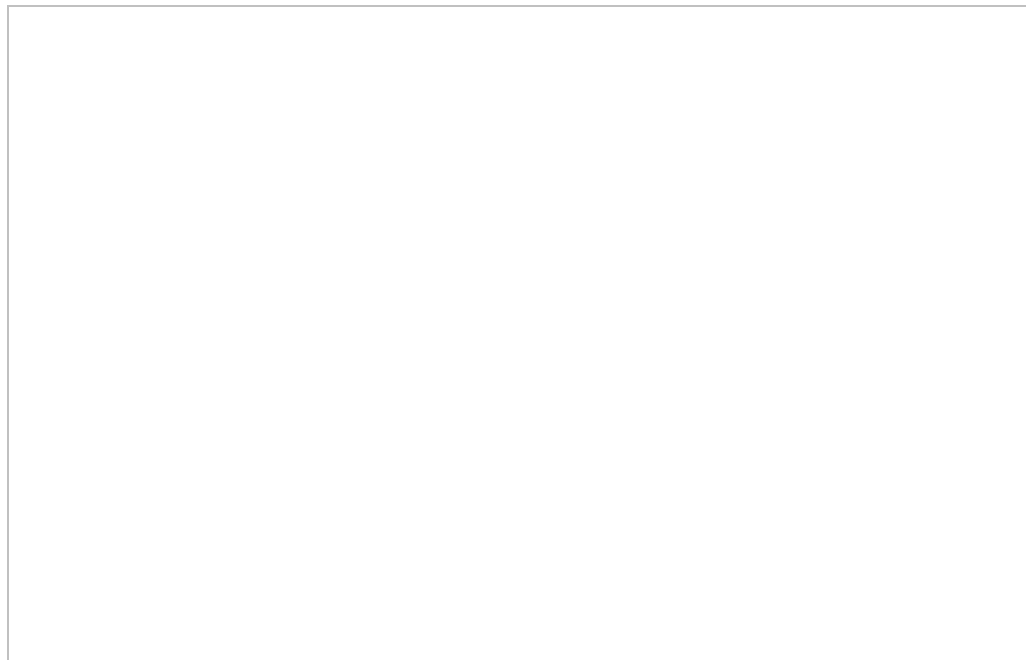
